Corn Maze

Guidelines for a safe, fun, and educational field trip experience!

These guidelines have been compiled to ensure that you arrive at the corn maze fully prepared for your field trip experience. Today's Harvest is located at an operational farm market and observing these guidelines will help assure you of a safe, relaxed, and thoroughly enjoyable time.

1. Upon arrival to Today's Harvest, LLC, please pull into our parking lot and pull up to the building. We ask that ONLY the teacher comes inside to notify us of the arrival. We will complete payment and explain where to park, unload, and where to congregate for introduction.
2. We ask that you are ON TIME and have PAYMENT READY. If your group is going to be late, please call 937-437-0166 and let us know. If your group is late, you might have to be worked into an opening.
3. Weather and Cancellations: We ask that you watch weather conditions prior to leaving for the field trip and have students dress accordingly. If the weather is questionable, please call us at 937-437-0166, as this is an outdoor field trip. If WE must cancel due to weather, WE will make every effort to reschedule your field trip. If YOU must cancel your field trip for reasons other than the weather, please give us at least two weeks' notice.
4. Duration of the field trip: The approximate time of the field trip is 2 hours. Groups larger than 100 should plan to stay about 2.5 hours. Your field trip is allowed to stay at the Corn Maze for up to 3 hours max. This should give the groups adequate time to do the corn maze, play the barnyard games, and of course LEARN!
5. Facilities: If your group would like to have a picnic lunch or snack, you are welcome to bring packed lunch or snacks. We have picnic tables, portable toilets, handwashing stations, and other restrooms.
6. Clothing: Please dress accordingly; this is an outdoor activity. You will be walking on uneven ground. It is dirt, so of course if it has rained, it could be muddy. We have a shoe washing station available. We recommend wearing tennis shoes, blue jeans and t-shirt. Since you are walking around you normally keep warm, but a light jacket or sweatshirt will be needed when temperatures start to cool.
7. If your group gets pumpkins, teachers are responsible for bringing large boxes to transport the pumpkins back to the school.
8. We welcome chaperones accompanying their children/grandchildren. Please notify the chaperones that upon arrival they will be charged for the field trip, if they are outside of the allowed 5 free chaperones. They will also need to bring their own lunch/snacks as we will only have snack foods available for purchase.
9. Please remember to bring your camera to capture all the events of that day.
10.
